

FIFRA Enforcement in Focus: Navigating Oversight in a Changing Regulatory Landscape

With increased scrutiny at the U.S. border and evolving enforcement priorities under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), companies in the antimicrobial and pesticide sectors face growing regulatory risk, often without realizing they are on the radar.
